Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of **200000.00 (Two Lakhs Rupees Only)**, which shall be valid for 30 days beyond the validity period of the bid.
