Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of 200000.00 (Two Lakhs Rupces Only), which shall be valid for 30 days beyond the validity period of the bid.
