Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **5,00,000.00 (Five Lakhs Rupees Only)**, which shall be valid for 30 days beyond the validity period of the bid .
