Late bids will be rejected. Bids will be opened electronically at 2:00 PM on the same day of bid submission in the presence of the bidders or their representatives who choose to attend.
4. Pre-bid meeting will be held in the Mahalaxmi Municipality at 2:00 PM on 2076/02/01. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting
